## **NOTICE FOR E-AUCTION OF LINEN ITEMS**

Bids are invited from eligible agencies for the E-Auction of **2100 kgs (Two Thousand One Hundred Kilograms) ON AS IS WHERE IS BASIS** of Linen Items lying in the basement of ESIC Super Speciality Hospital, Sanathnagar, Hyderabad-500038.

The E-Auction will be conducted in accordance with the General Financial Rules (GFR)-2017, Central Vigilance Commission (CVC) guidelines and applicable waste disposal guidelines issued by the Central Government and Government of Telangana.

### 1. Item for Auction:

- Description: Linen Items (Old Bed sheets, pillow cover and blankets (disinfected), Year of Make 2022)
- Quantity: 2100 kgs
- Location: Basement of ESIC Super Speciality Hospital, Sanathnagar, Hyderabad-500038

### 2. Important Dates & Time:

- Last Date for Lifting of Material by Successful Bidder: Within 7 working days from the date of issuance of the work order.

## 3. Eligibility Criteria for Bidders:

- The bidder must be a registered firm/agency/company.
- The bidder must possess valid licenses from any of the Authorized Department for sale of scrap.
- The bidder should have a valid PAN/TAN and GSTIN.
- The bidder should not have been blacklisted by any Government Department / PSU / Autonomous Body.

## 4. Earnest Money Deposit:

A refundable EMD of **Rs. 2000/**- (Rupees Two Thousand Only) must be submitted by way of a Demand Draft/Banker's Cheque drawn in favour of "ESIC Fund Account No. 1" payable at Hyderabad, before E-Auction. The bidder who does not submit the EMD will not be allowed in the E-Auction. The EMD of unsuccessful bidders will be returned without interest after the completion of the auction process. - **5. No claims regarding the quantity, quality or condition of the material will be entertained at the time of E-Auction. The scrap will be sold on "as is where is" and "as is what is" basis.
- **6. Reserve Price:** The reserve price for the Linen Items is fixed at **Rs. 10,500/-** (Rupees Ten thousand and five hundred Only). Bids below the reserve price will not be considered.
- **7. Bid Submission:** Bids must be submitted in GeM. The final bid must include the duly filled **Annexure-A** (Price Bid Format) as provided below, for the **Linen Items**, both in figures and words, including all applicable taxes. The submitted bid shall remain valid for a period of 90 days from the date of E-Auction.

- **8. Acceptance of Bid:** The Medical Superintendent, ESIC Super Speciality Hospital, Sanathnagar, Hyderabad reserves the right to accept or reject any or all bids without assigning any reason thereof. The decision of the Medical Superintendent shall be final and binding on all bidders. The highest acceptable bid (equal to or above the reserve price) will ordinarily be selected.
- **9. Payment Terms:** The successful bidder will be required to make the full payment for the auctioned material within 5 working days from the date of issuance of the work order, through a Demand Draft/Banker's Cheque in favour of "ESIC Fund Account No. 1" payable at Hyderabad. All applicable taxes (e.g., GST, etc.) shall be borne by the successful bidder as per prevailing government rules. Lifting of material will be permitted only after the full payment has been received and cleared. **10. Lifting of Material:** The successful bidder shall be responsible for the complete removal and transportation of all auctioned **Linen Items** from the ESIC Hospital premises within 07 working days from the date of issuance of the work order, at their own cost and risk. This includes providing their own labour, vehicles, and any necessary equipment.
- **11. Safety and Compliance:** The successful bidder shall ensure that all necessary safety precautions are strictly adhered to during the lifting and transportation of the material. The bidder shall comply with all relevant labour laws, environmental regulations and traffic rules. ESIC Super Speciality Hospital, Sanathnagar will not be responsible for any injury, accident or damage caused to the bidder's personnel, vehicles or any third party during the process.
- 12. Weighment: The responsibility of arranging and bearing all costs related to the weighment of the Linen Items at the time of lifting shall lie entirely with the successful bidder. The actual weight of the material will be jointly recorded in the presence of authorized representatives of Super Speciality Hospital, Sanathnagar and the bidder/bidder's representative at the time of removal and the total payable amount shall be calculated accordingly based on the approved bid rate per kg.

  13. Forfeiture: In case the successful bidder fails to make the full payment or remove the material within the prescribed time, the EMD shall be forfeited.
- **14. Scrap Disposal:** The bidder is responsible for all transportation, handling and lawful disposal complying strictly with Central and Telangana State Waste Management Rules. Disposal must be eco friendly and in accordance with the waste disposal guidelines issued by the concerned authorities.
- **15. Governing Law and Jurisdiction:** The auction process and any disputes arising thereof shall be governed by Indian laws and subject to the exclusive jurisdiction of the Courts in Hyderabad.
